Registration of interest for a Nursery Place

15-hour funding

At Masefield, the term after your child turns 3 years old, they are eligible for 15 hours of free provision per week, which is offered over 5 morning sessions (Mon-Fri 8:45am-11:45am)

However, 15 hours funding can also be used over 2.5 days, with an additional fee of £3.50 per day to cover the extra 45 minutes of care per day, however this is dependent on availability. Additional sessions can also be paid for to increase the 15 hours provision and are outlined below.

Additional hours

Parents can pay for additional hours if they need more than the 15 hours of free provision per week. Hours of attendance and allocation of sessions, once agreed, will be set for the term.

The fees for the extended provision are:

Full week provision (5 full days)	15 hours	£89 per week
Extra morning or afternoon session	3 hours	£17 per session
15-hour full day – outside entitlement hours (45 mins)		£3.50 per day

School meal (current price – subject to change) £2.65 per day/£13.25 weekly

Packed lunch provided by parent/carer. No charge for meal.

30 Hours Funding

You must apply for your 30-hour funding the term before your child is due to start Nursery. To see if you are entitled to 30-hour funding please visit childcarechoices.gov.uk.

Once you have been allocated a code, please let school know so it can be verified.

The fees for the 30-hour funding are:

30 hours taken over four and a half days £0

Extra hours taken to increase to five full days £17.50

School meal (current price – subject to change) £2.65 per day/£13.25 weekly

Packed lunch provided by parent/carer. No charge for meal.

Fees are payable one week in advance and can be paid weekly, monthly or for the full term by cash or online payment through My Child At School (MCAS). A contract will be drawn up and you will have to sign and agree to the terms and conditions for nursery provision. Payment can also be made through childcare vouchers/ tax free childcare but cannot be used to pay for school meals or trips.

All fees will be subject to regular review
